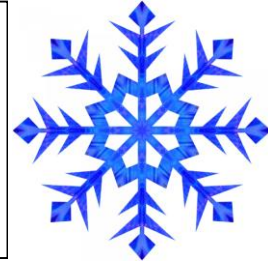
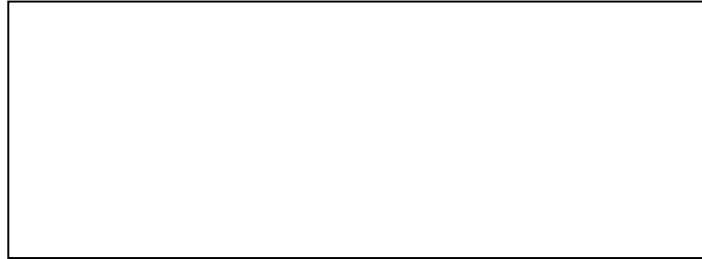
In addition, meaningful Memorial Services were held following CDC guidelines. This is an important part of our service to Members and their families. "Elks are never forgotten, never forsaken."
